- Toilets \$250. Maximum 2 toilet rebates per site. **Customers must replace an existing 1.6 GPF toilet or higher.**
- Clothes Washer (Residential only) \$250. Maximum 1 rebate per household. **Must meet or exceed CEE Tier 1 Standard**
- Ultra Low Water Urinals \$400. Maximum 4 urinal rebates per site. **Customers must replace an existing 1.5 GPF urinal or higher.**
- Waterless Urinals \$500. Maximum 4 urinal rebates per site. **Customers must replace an existing 1.5 GPF urinal or higher.**
- Flush Valve Toilets \$400. Maximum 2 toilet rebates per site. **Customers must replace an existing 1.6 GPF toilet or higher.**
- Air Cooled Ice Machines \$1,250. Maximum 1 rebate per site. **Must replace an existing non air cooled ice machine.**

Required Application Submittal Items:

- A completed copy of this application page;
- A signed copy of the terms and conditions;
- A copy of your most recent water bill;
- A legible picture of EACH existing device(s) you are applying for;
- Completion of a pre-inspection if requested.

Required Final Submittal Items:

- A photo of each installed device;
- A receipt for each device showing payment;
- Completion of a post-installation inspection if requested;
- A complete W-9 form (If applicable).
- A copy of the final permit from Building & Safety (Toilets/Urinals Only)

Please submit your items to our customer service team to review. You may purchase your device once you have been provided a notice to proceed. Customers who start their project prior to receiving a notice to proceed will be denied.
