

**City of Camarillo's
Water Conservation Devices Rebate Program
Terms & Conditions and Hold Harmless Agreement**

I give permission to WaterWise Consulting, Inc. (WaterWise) representatives to enter my property to perform an inspection for eligibility for water conservation device rebates. I acknowledge that the inspection is voluntary and a requirement for participation in the program if I am selected for an inspection. After completion of the inspection and all other application requirements, I may decide to install devices after I receive a Notice to Proceed.

I acknowledge that I may not qualify for all devices I have applied for, and the Notice to Proceed will provide me with information on which device(s) I qualify for a rebate for. If I choose to install the approved device(s), I acknowledge that I will have 60 days to install the device(s) and provide photographic proof of the installation(s) to WaterWise Consulting. I acknowledge that if I do not install the device(s) and submit proof of installation within 60 days, I will forfeit eligibility for rebates offered through this program. I acknowledge that the installed device(s) must be on the Qualifying Products list. Participants' purchases prior to March 1, 2021 will not qualify. Customers must receive approval (Notice to Proceed) prior to purchasing devices otherwise they may be ineligible for the program.

Permit - The City requires each customer to obtain a **no cost** permit in order to receive the toilet rebate. Customers may obtain a permit by filling out the application available online at the City's website and emailing it to bldgsafe@cityofcamarillo.org or submit it to the Building & Safety counter at City Hall, located at 601 Carmen Drive, Camarillo, CA 93010. An inspection from Building & Safety is required to verify the device is installed correctly and to receive the rebate.

In exchange for the anticipated benefit from participation in the program, I hereby agree to give trained inspectors from WaterWise, on behalf of the City of Camarillo ("Camarillo") permission to enter my property for the purpose of conducting the inspection. I understand that this program is not open to new construction. I hereby agree to fully cooperate with the inspector.

I agree to defend, indemnify and hold harmless Camarillo and WaterWise and their respective subcontractors, directors, officer, officials, employees, consultants and agents, from any and all claims, damage, or liability resulting from participation in the Program, including but not limited to any loss or liability arising out of installing any of the water saving devices or the use thereof

The goal of the Program is to provide rebates to offset the cost of water savings devices for customers. Not all customers will qualify for the rebates that are provided in this program. Rebates are available while supplies last. New construction is not eligible for participation in this Program. Actual water savings will vary depending on selected device(s) and water use habits. WaterWise is a fully licensed Corporation, bonded C-27 Landscape Contractor (#975874) licensed by the State of California. For device warranties, please contact the manufacturer of your device(s).
